

# ARE YOU ON A PRIVATE WELL?

## Pending Legislation could affect you!

BDR 48-183

Creates a single authority to oversee all water issues in Washoe County. As drafted, the Northern Nevada Water Authority would have complete control, including:

- \* Identification, development, planning and management of water resources.
- \* Use of Eminent Domain to obtain water.
- \* No protection for domestic wells.
- \* No representation for domestic wells on the new Commission or Board.

The Bill Draft goes beyond the recommendations of SCR 26 and calls for measures that the District Attorney and the Washoe County Board of County Commissioners recommended changed.
